- 7- That no complaint/inquiry is pending against school property/management committee of the school seeking recognition.

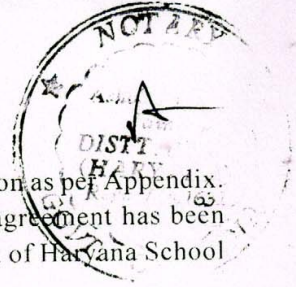
